Project abstract:

Although a growing body of evidence on both offline and technology-facilitated child sexual exploitation and abuse (CSEA) has been published and widely disseminated, estimating the full extent of these crimes remains challenging due to their hidden nature and the fragmentation of available data. Sexual violence is a complex issue that manifests in multiple forms, including contact violence including rape and sexual assault, "offline" non-contact child sexual violence and sexual exploitation. Each type presents unique challenges and consequences that necessitate tailored response crucial for developing effective prevention, intervention, and support strategies. This systematic review aims to address gaps in understanding of the prevalence of “offline” CSEA at the country and regional levels across North America, East Asia & Pacific, and Latin America & the Caribbean. This review forms part of a broader programme of work examining both technology-facilitated and “offline” CSEA, and is intended to complement other data activities undertaken for the Childlight Global Index, including analyses of administrative data related to CSEA and child sexual abuse material (CSAM). By analysing and synthesising existing literature, this review will provide crucial evidence that can inform policy making and practice regarding the prevention of and response to CSEA. The findings of this review will be of great significance to policymakers, practitioners, advocates and researchers, as they can use the evidence to make informed decisions about allocating resources and designing effective prevention and response programs. The current review will serve as a benchmark for future regional analyses to ensure methodological consistency and comparability across subsequent years.

The research team searched the following electronic databases for journal articles/reports that meet the inclusion criteria:

- PubMed/Medline (ovid),
- Global Health (ovid),
- PsycINFO (ovid),

- EMBASE (ovid),
- Social science citation index (Web of Science)
- Sociological abstracts (ProQuest)),
- CINAHL (EBSCOhost),
- ERIC (EBSCOhost),

- Google Scholar,
- Scopus,
- ProQuest Dissertations & Theses Global.

In addition, articles will be hand reviewed from the following journals that are key in the field of child protection: 'Trauma, Violence & Abuse', 'Child Abuse and Neglect', 'Child Maltreatment', 'Child Abuse Review', and 'Journal of Interpersonal Violence'.

Searches will be conducted using English-language search terms without language restrictions, covering publications from January 1, 2025 to January 1, 2026. Eligible studies may be published in English, Spanish, Portuguese, French, Chinese, Japanese, Korean, or Thai, reflecting the primary languages used across North America, East Asia and the Pacific, and Latin America and the Caribbean. This will update prior global systematic reviews that included studies between January 1st 2010 and December 31st 2024. Additionally, scoping searches will be conducted using the main electronic databases (Embase, ERIC, PsychInfo) for literature from North America, East Asia & Pacific and Latin America & Caribbean, published in other languages. The DistillerSR systematic review software (Version 2.35., DistillerSR Inc.; 2023; <https://www.distillersr.com/>) will be used to compile relevant peer-reviewed sources. Duplicate entries will be removed.

Key grey literature sources include research done by international non-governmental organizations (INGOs), UN agencies and community-based organizations (CBOs), as well as research reports from national government sources will also be searched. A thorough scan of key websites publishing CSEA studies will be completed. This scan will help to identify both grey literature and organizations/individuals that may have links to grey literature.
